As a reminder, the 2022 federal reporting season is approaching! Prep for two of HUD's major CoC reports will begin in October: the Longitudinal Systems Analysis (LSA) and System Performance Measures (SPM).

### [GNRL-220] Program Details Report

The [GNRL-220] Program Details Report is based on project enrollments. Clients without an enrollment will not be included in the Program Details Report.

#### Purpose

The Program Details Report returns all the fields and corresponding responses for selected screens. Additionally, the report provides some profile and Housing Service information, depending on the screen selected.

#### Running the Report

##### Who Can Run the Report

Anyone can run the report but the returned information will be limited based on the access rights of the user.

An Administrator version of the report is also available [GNRL-220-AD]. System administrators and users with additional access can run the report across multiple agencies.

### Training Recap: HMIS 101 Training/FAQ Recap

The Monthly Agency Utilization Report is a report that generates unique client In October, our King County Community Administration team hosted for the very first time, an HMIS Governance 101 training and overview. We hosted this training on Wednesday, October 5<sup>th</sup> with the hopes of providing a general overview of how HMIS operates in King County and what the expectations are for agencies and individuals who may be new to HMIS or are considering joining our HMIS database.

#### Here are the key topics and highlights of the training:

- Objective of training - aimed at giving newer partnering agencies and their staff a full overview of the KC HMIS instance (Background of Bitfocus and Clarity Software)
- Focused on the process of agencies being added to HMIS (MOUs, TASOs, and approval process)
- KCRHA capacity team presented on how they support partnering agencies with internal structure and building capacity for such agencies to effectively support the populations they serve.
