[DQXX-121] Project Start Date > Project Exit Date

Type of Report

This is a project enrollment-based report.

Purpose of Report

This report offers a proactive view of project enrollments where the Project Exit Date is before the Project Start Date. These situations can occur during data integration and in some situations where the project start or exit date is updated after the fact.

Report Location

The report is found in the Data Quality section of the Report Library. Also, there is an admin version available in the Administrator section.

Who Can Run the Report

Anyone can run the report with constraints based on the access rights of the user.
