### Preparing Your HMIS Data for Point-in-Time Count

Whether or not a community conducts Point-in-Time (PIT) **unsheltered** ("street") count this year, the PIT **sheltered** count of individuals and families experiencing homelessness must occur. This year the PIT will occur on different dates for some of Nevada's communities, so please refer to the latest guidance from your CoC. Data for this count comes exclusively from HMIS. It is critical that all emergency shelter, safe haven, and transitional housing projects in HMIS reflect accurate enrollments, exits, and night-by-night services for your community's PIT night as part of this annual count of households experiencing homelessness in Nevada.
