Preparing Your ONE System Data for the Point-in-Time Count

Whether or not a community conducts Point-in-Time (PIT) unsheltered ("street") count this year, the PIT sheltered count of individuals and families

experiencing homelessness must occur. This year, the PIT will occur on **February 23, 2022**. Data for this count comes exclusively from the ONE System. It is critical that all emergency shelter, safe haven, and transitional housing projects in the ONE System reflect accurate enrollments, exits, and night-by-night services for the February 23, 2022 night as part of this annual count of households experiencing homelessness in San Francisco.

Review Your Data for the Point-in-Time Count

The San Francisco sheltered Point-in-Time Count will occur on **February 23, 2022**. This means that you will need to make sure your shelter, transitional housing or permanent housing program has complete and up-to-date data for the night of **February 23, 2022**, and make sure it's entered into ONE System no later than **February 25, 2022**. To check your data, please run the following reports as soon as your **February 23, 2022** enrollments, exits, and services are entered.
