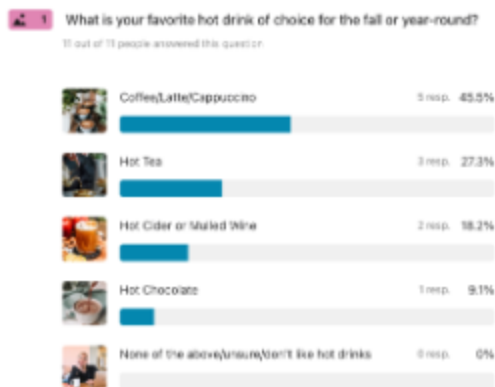

HIC Updates & Next Steps

This year SCC will not be doing an Unhoused Count; therefore, we will only be focusing on the HIC (Housing Inventory Count). The date that has been selected for the HIC this year is **Thursday, January 25, 2024**. Reports run for Data Quality should focus on this date.

What's the HIC

- The Housing Inventory Count (HIC) is a point-in-time inventory of programs within a CoC that provide beds and units dedicated to serve people experiencing homelessness, and for permanent housing projects where the client is homeless at entry.
- The HIC also provides information on the number of unduplicated clients sheltered and housed on the night of the PIT count.
- All homeless-dedicated beds must be included, regardless of funding source or whether they use the HMIS.
- This data is pulled directly from the HMIS and must be collected externally from non-participating programs.

Project Types included on the HIC

- Emergency Shelter (ES)
- Transitional Housing (TH)
- Safe Haven
- Rapid Re-Housing (RRH)
- Permanent Supportive Housing (PSH)

- Other Permanent Housing (OPH)

Data Quality

Review relevant data on 01/25/2024

- Demographic data (DOB, Gender, Race & Ethnicity)
- Enrollment/Exit data (Head of Household [HoH]), Move-in Dates, Bed Nights, Chronically Homeless, Disability)
- Project Descriptor data – Review Bed and Unit Inventories and Project Types
- Utilization Rates – Do counts of clients housed seem too high (over 100%) or too low (under 65%)

Report Spotlight

[HUDX-123-AD] Housing Inventory County (HIC) Supplemental

The Housing Inventory Count Supplemental report is designed to be used as a tool to review housing inventory available in a community that is dedicated for homeless persons. The report also offers a point-in-time look at utilization.

Running the Report

Due to the nature of this report and the information available in the drill downs, it is included in the Administrator section of the Report Library. The report works for both methods of managing bed inventory in Clarity Human Services -- at the program level and through the Inventory module.

Who Can Run the Report

System Administrators and users with additional access can run the report across multiple agencies.

SCC HMIS Quarterly Compliance Certification Checklist – DUE 01/31/2024

We ask that when you send your certification to our team, you also complete this form, providing the names and email addresses of Non-HMIS Assessors at your agency. These are staff who DO NOT have HMIS access but complete paper VI-SPDATs to clients. Most of you will not have staff that do this but we want to make sure to capture this information in order to ensure that any updates to VI-SPDATs are sent to them.



Updates

Reminder: Coordinated Entry (CE) Assessments Missing Referral to the CQ

- **Please remember that we have a new process** in which the Agency Lead is responsible for running the report for Clients who were administered a VI-SPDAT but were not referred to the Community Housing Queue (CHQ).
- **We recommend you run this report bi-weekly** to avoid having a large number of clients who may need a referral
- **This report shows you** clients who were assessed over the last year but are not currently on the Community Housing Queue. Please review the client record to ensure they still need to be on the Community Housing Queue before referring. You may have clients who are missing referrals but do not need to be referred.
