2022 Federal Reports Updates

The 2022 federal reporting season is here! Last month we started data clean-up for The Longitudinal Systems Analysis (LSA) and System Performance Measures (SPM) CoC reports. We looked at data quality around overlapping enrollments, program enrollments where the start and end date don't line up, length of stay, and utilization in programs where there is a bed and unit count. Over the next

month, we will add communications regarding data quality for program inventory, funding sources, and additional types of bed errors. Thank you for your patience and quick responses!

[DQXX-121] Project Start Date > Project Exit Date

This report offers a proactive view of project enrollments where the Project Exit Date is before the Project Start Date. These situations can occur during data integration and in some situations where the project start or exit date is updated after the fact.

To run the [DQXX-121] Project Start Data > Project Exit Date:

• Log into Clarity and navigate to the Report Library (Reports under the Launcher menu in the upper right corner).

- Locate [DQXX-121] Project Start Date > Project Exit Date under the Data Quality Reports Section.
- Under Report Output Format select Web Page, PDF or Excel (choosing Web Page will allow you to click on the client name or ID and automatically open up the client profile in Clarity Human Services.
- Click the OK button.



Coordinated Entry Events are Live!

Communities are now able to set up and record inferred Coordinated Entry events as manual events if desired (inferred events are recorded automatically by the system; manual events are recorded by the user in the client enrollment record). Manual events will now be configured and recorded within a programlevel Events tab instead of through services.

While many agencies with inferred Coordinated Entry events will not see any change, some agencies saw an update in their Service tab in Clarity. Now, within the program enrollment, there is an Events tab alongside the Service tab.
