




Permanent Housing Programs: Housing Move-in Date

The housing move-in date refers to the date a household will physically begin sleeping in their new permanent unit. This date is critical in differentiating between those who are housed within a permanent housing program and those who are still working toward moving into their new home. When reviewing client program details, please be on the lookout for these common errors:









Error The move-in date is overlapping with another 'sheltered' program The client cannot physically occupy more than one space at a time Solution Review client's program history and coordinate with others to correct



Commonly Asked Questions

Question	Answer
What happens when a household remains working with the same program, but moves from one unit to another <u>without any days of</u> <u>homelessness</u> in between?	It is not necessary to exit and reenroll them. The move-in date would still accurately reflect the day they entered permanent housing according to that enrollment record.
What happens when a household transfers programs, but remains in the same unit?	The enrollment and move-in date of the new program would be the day after the first program ends.
	It is not necessary or appropriate to have the original housing move-in date reflected in the new program since the purpose of this data element is to distinguish between housed and homeless status within an enrollment.
Is the move-in date the same as the "lease date?"	HUD defines the move-in date as the date the household is physically sleeping in the unit; sometimes with corresponds with the lease date, but it doesn't have to.
What happens if the household never moves into a unit?	Do not enter a move-in date and exit from the program to the accurate destination when appropriate.
What happens if there appears to be an overlapping enrollment?	Contact the program to verify/update their data.
