FY2024 HUD Data Standards Updates

2024 HMIS Data Standards go live on October 1, 2023

Data collection screens will change slightly to comply with the updated standards

Let's review the release timeline and ONE updates...



Report Library Release Timeline

Training, Live, and Migration Sites:

- --+ Updated federal reports (APR, CAPER, CSV Export, etc.) available October 1.
- --+Old versions will be archived, no longer available after October 1.
- --> Updated Data Analysis reports will follow.



New SSVF Services:

Financial Assistance services – one service item renamed, two service items added:

- --+"Extended Shallow Subsidy Rental Assistance" relabeled "Shallow Subsidy – Financial Assistance"
- --> New Landlord Incentive
- --> New Tenant Incentive
