Custom migration includes all data not included in the HUD migration. **The custom migration phase typically begins after go-live.**

Below are examples of data you may want to migrate during the Custom Migration phase. The custom file in which this data will be migrated is also included. There are 13 custom file types that can be migrated into Clarity Human Services. For more detailed instruction on each custom file type, please see the HUD and Custom Migration Instructions. For more detail on formatting your custom data for import, please see the Bitfocus Custom CSV Import Schema. Please note, every database is different and examples may not apply to your system.
